Pennsylvania State Board of Pharmacy Licensure Requirements

All applicants to pharmacy residencies at Allegheny General Hospital must be eligible for pharmacist licensure in Pennsylvania (PA). Information about licensure and the PA Licensing System (PALS) can be found at the PA Department of State, Bureau of Professional and Occupational Affairs, Professional Licensing site:

Candidates from Pharm.D. Programs

Eligible candidates for PA licensure testing must have:

- 1) graduated with a Pharm.D. from an school of pharmacy accredited by the Accreditation Council for Pharmacy Education (ACPE)
- 2) completed at least 1,500 internship hours from an ACPE-accredited Pharm.D. program (all hours are accepted)
- 3) completed the education requirements: 3-hours of training in child abuse recognition and reporting provided by a Board approved education provider AND 4-hours of training about opioids, with 2-hours allocated to pain management or the identification of addiction and 2-hours allocated to the practices of prescribing and dispensing of opioids
- 4) provided Criminal History Records Check information (see website above for more details)
- 5) provided National Practitioner Data Bank Self-Inquiry report
- 6) requested license verification for any license to practice any health-related profession

An official verification education and internship hours, opioid CE if part of the school training program, criminal background record, and prior licensure must be **mailed directly from the school, another state's board(s), another state's police and/or the FBI** to the Pennsylvania State Board of Pharmacy (PO Box 2649, Harrisburg, PA 17105-2649, 717.783.7156)

Candidates with a B.S. in Pharmacy or have FPGEC Certification

Candidates with a B.S. in Pharmacy from an ACPE accredited school of pharmacy or FPGEC certification seeking to reciprocate licensure to PA must meet the requirements outlined above with exception to the internship hours requirement. Of the minimum 1,500 hours internship hours required, at least 500 hours must be demonstrated to have been earned outside of school and in a licensed pharmacy. If the internship hours requirement cannot be verified, the Board may be able to accept one year (a full 365 days) of full-time practice of pharmacy in another state or completion of a one-year pharmacy residency within the U.S.
